In Re: E-Filing System and E-Filing Policies

The South Carolina Administrative Law Court (ALC) has embraced the use of information technologies to increase the effectiveness, efficiency, and accessibility of the courts. The ALC thus recognizes the need for an E-Filing System for the electronic exchange of documents with the Court.

The design of the ALC's E-Filing System has now been completed. To implement the E-Filing System, the Court adopted ALC E-Filing Policies pursuant to SCALC Rule 4(B) on September 29, 2022. The Court believes that the best way to commence e-filing is to first allow for the voluntary usage of the E-Filing System. Beginning on December 1, 2024, the ALC approves the voluntary usage of the E-Filing System for court filings by authorized attorneys. All e-filings shall be consistent with the ALC E-Filing Policies as provided under SCALC Rule 4(B).
